### **Tournament Guidelines**

- 1. Each team may list 15 players on their roster.
- 2. Grain Valley will provide practice balls for all pools.
- 3. Coaches will be responsible for valuables belonging to their team.
- 4. Entry fee is \$275 per school. Mail checks to: Grain Valley Schools, Attn: Brandon Hart, PO Box 304, Grain Valley, MO 64029
- 5. Each school must provide a line judge for their matches.
- 6. Hospitality rooms will be available for officials, coaches, and admin.
- 7. Concessions will be available
- 8. Warm-up will be 2-2-1 after each team's first match during pool play and 5-5-5-1 before each teams first match during bracket play. Please have your teams ready to play in case we are ahead of schedule.

#### Admission: Adults/Students (age 6 and above) - \$5

## **Parking**: Due to limited parking, <u>buses may not park at the Fieldhouse</u>. Buses may choose to park across

the street in the Wal-Mart parking lot, or may park at GVHS which is approximately 4 miles from the Fieldhouse. Please enter the facility on the East side (in the back).

**POOL PLAY:** Pool play will consist of 2 games of 25 points (win by 2), starting at 4 – 4.

Teams 1 & 2 from pool play will proceed to the Championship bracket, while teams 3 & 4 from pool play will proceed in the consolation bracket. Seeding will be based upon your finish in pool play.
